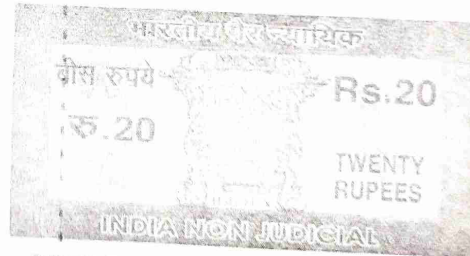

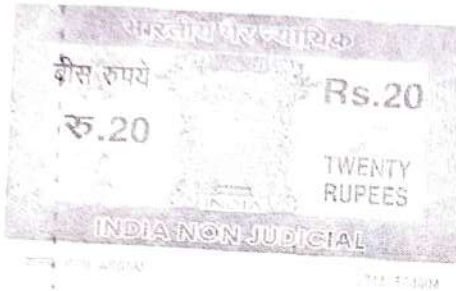

Either party may terminate the Agreement with six (6) months' written notice of intent to terminate.

6. Neither party is obligated to expend any resources In connection with this Agreement. To the extent that resources are expended In connection with this Agreement, each party is responsible for the resources necessary to perform its obligations under this Agreement. No implementation of any portion of this Agreement or commencement of any specific projects may be initiated prior to the written assurance of adequate budgetary resources. DBCg and SPCM may jointly or individually seek funding and other support from third parties to support activities under this Agreement.

7. This Agreement shall not be construed to create a relationship of partners, brokers, employees, servants, joint venture or agents as between the parties. 
